Special Instructions

- Spray in sufficient gallonage to obtain good coverage of entire tree.
- Apply approximately 5 to 10 gallons of the 9.6 fl oz per 100 gallon of dilution per tree with high volume sprayers. With low volume sprayers apply 100 gallons of the 52 fl oz per 100 gallon dilution per acre.
- Apply when flowers are receptive and repeat application 14 days later.
- Do not graze or harvest cover crop.
- Refer to spray requirements on the container label when applying to areas adjacent to water.
