Apply with sufficient water to allow for penetration into the foliage to obtain complete coverage using 50 to 100 gallons of spray volume per acre. Continue as needed on a 14 to 21 day interval. When disease pressure is severe, use shorter intervals.
	leaf spot (Phomopsis viticola)	8.5 fl oz	Resistance Management: Do not make more than 2 sequential applications of this product or other Group 3 or Group 7 containing fungicides before rotating to a fungicide with a different mode of action. Do not apply a third application of this product within 28 days of the second application.
			Restrictions: Do Not apply more than 25.5 fl oz/A/year The Pre-Harvest Interval (PHI) for this crop is 14 days. This product may be applied via aerial application equipment except in the State of New York. Do Not apply more than the maximum yearly rate from any combination of products containing Isofetamid (1.72 lb. a.i. per acre per year) or Tebuconazole (0.9 lb. a.i. per acre per year) to these crops.
