USE PRECAUTIONS

The addition of an adjuvant to some pesticides may increase the risk of phytotoxicity to certain susceptible crops, especially during periods of high humidity or other circumstances which may increase the activity of spray solutions. Care should be exercised when using on new varieties or crops not previously treated with Veracity Elite II.

HAZARD STATEMENTS

Causes eye irritation. Causes mild skin irritation. May cause an allergic skin reaction. May cause damage to organs (kidney) through prolonged or repeated exposure.

PRECAUTIONARY STATEMENTS

Read label before use. Store between 32°F and 90°F. Store in tightly closed container. Avoid breathing dust, fume, gas, mist, vapors and spray. Wash thoroughly after handling. Use only outdoors or in a well-ventilated area. Contaminated work clothing should not be allowed out of the workplace. Dispose of contents and container in accordance with local and national regulations.

DIRECTIONS FOR USE

NOT FOR AQUATIC USE

Use only if a nonionic surfactant (NIS), water conditioner, drift reduction technology (DRT), and deposition agent are allowed or not excluded on the label. Veracity Elite II does NOT contain ammonium sulfate (AMS). NOTE: When combining new or unfamiliar components in any tank mix, the applicator should conduct phytotoxicity and jar tests to ensure compatibility and avoid damage to non-targeted species. Always follow the directions on the most restrictive active ingredient label. Tank mixtures should only be applied within the label recommendations of every product in the tank mixture.

USE RATES

For use with herbicides registered for use for agriculture, forestry, and industrial, municipal, ornamental, right-of-way, turf, non-cropland and other use. Prior to using Veracity Elite II, the user or application advisor must have experience with the combination of active ingredients or must have conducted a phytotoxicity trial.

AERIAL, GROUND OR CDA APPLICATION RATES

For General Use	2 to 8 pints per 100 gallons
For Use As a Drift Reduction Agent (DRA) With Approved Dicamba Products	5 pints per 100 gallons
To Buffer the Spray Mixture to a Higher pH	8 pints per 100 gallons

DO NOT USE VERACITY ELITE II AT A RATE TO EXCEED 1% V/V OF FINISHED SPRAY TANK MIXTURE.

MIXING DIRECTIONS

Prior to any pesticide application, all spray equipment must be thoroughly cleaned. Carefully observe all tank cleaning directions on the pesticide label. Do not mix Veracity Elite II with undiluted herbicides. Unless instructed otherwise by accompanying pesticide label instructions, fill spray tank 1/2 full with water, add Veracity Elite II first then continue filling tank. Add remaining pesticide or nutrient ingredients consistent with respective label directions.

STORAGE, DISPOSAL AND SPILL

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store between 32°F and 90°F. Store in original tightly closed container in a dry, well ventilated area, away from excessive heat and incompatibles. Do not store in iron, copper or aluminum containers or equipment. Do not store with food, feed or other material to be used or consumed by humans or animals. Do not contaminate water supplies.

Disposal: Dispose of contents/container in accordance with local/national regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations. Spill: In the event of a major spill, fire or other emergency, call CHEMTREC at (800) 424-9300.

Fire: In case of fire, use alcohol resistant foam, CO₂, powder or water spray to extinguish.

GENERAL INFORMATION

Veracity Elite® II is a drift reduction and water conditioning agent formulated specifically for dicamba tank mixes to reduce off-target drift. Veracity Elite II imparts a neutral pH. Veracity Elite II can eliminate antagonism of the spray tank caused by hard water minerals such as calcium, iron and magnesium. The surfactant ingredient in Veracity Elite II improves spray droplet spreading and penetration into the targeted leaf surface. Veracity Elite II provides humectancy to spray droplets resulting in a slower drying time for enhanced uptake of active ingredients. Veracity Elite II can be used for a wide range of pesticide and nutrient spray mixtures when accompanying labels recommend water conditioners and spreader-wetter adjuvants.

FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor or going for treatment.

If in Eyes: Rinse continuously with water for several minutes. Remove contact lenses if present and easy to do; continue rinsing. If eye irritation persists, get medical attention.

If on Skin or Clothing: Rinse skin immediately with plenty of soap and water for 15 to 20 minutes. If skin irritation occurs, get medical attention. Take off contaminated clothing and wash before reuse.
