APPLICATION AND DIRECTIONS:

Apply at a rate of 50 grams per acre in enough water to penetrate into thatch, or irrigate immediately. Dissolve dry material in a bucket of water for 5 minutes. Decant liquid into sprayer tank. The remaining material in the bucket is only organic material and can be disposed of directly on the ground.

Micro Thatch can be used in conjunction with Pepzyme G, but only in early spring or fall.

CAUTION:

Keep out of reach of children and pets.
Do not swallow.
Do not mix with herbicides, fungicides, or insecticides.
Do not spray on wood buildings, fence posts, power poles, or telephone poles.

CONTAINS LIVE SOIL MICROBES:

Store below 120 degrees F.
