#### Application Timing:

Apply Fall Turf-prep  
October-November

#### Application Rate:

Apply at a rate of 5-7lbs/1000 Ft<sup>2</sup>

#### Spreader Settings:

Earth Grow	5-7.5
Earthway	7
Scotts	5-7
Vigoro	3-4

**\*Never apply Fall Turf-prep through a drop type spreader**
