Soybeans	Kudzu bug or Bean Plataspid	5.12-6.4 fl oz / acre. (0.08 – 0.1 lb ai/acre)

DIRECTIONS FOR USE:

Apply 5.12-6.4 fl oz/acre (0.08-0.1 lb ai/acre) Brigade Insecticide/Miticide by ground or aerial equipment using sufficient spray volume to obtain full coverage of the plant and foliage. Use a minimum of 2 gallons of finished spray per acre by air or 10 gallons of finished spray per acre by ground. The addition of 1 – 2 quarts of emulsified oil per acre to the spray solution may improve spray deposition and insect control. Apply as required by scouting. Timing and frequency of applications should be based upon insect populations reaching locally determined economic thresholds.

RESTRICTIONS:

Do not apply more than 19.2 fluid ounces product (0.3 lbs active ingredient) per season.
Do not apply within 18 days of harvest.
