2. HAZARDS IDENTIFICATION SUMMARY

KEEP OUT OF REACH OF CHILDREN - CAUTION - May cause mild eye and skin irritation. Avoid contact with skin, eyes, open cuts, or sores. In case of contact, flush with water. Get medical attention for eyes. This blended liquid nutrient is derived from Potassium Hydroxide, Calcium Carbonate, and Phosphorous Acid. Nausea and vomiting could be expected upon large dose ingestion. The acute ingestive effects are described as nausea, chills, and diarrhea. Eye or skin contact with these products could cause irritation (particularly in sensitive persons), and respiratory irritation could be expected from the unprotected inhalation of fertilizer mists. Product users should avoid prolonged or repeated skin contact by wearing impervious gloves, long sleeve shirt, long pants, socks and rubber boots. Goggles for eye protection are recommended. Wash thoroughly after handling and using this product.

This product is a clear, colorless liquid with no odor. Primary routes of entry are Inhalation, eye contact and skin contact.

4. FIRST AID MEASURES

If in eyes: Flush eyes with clean running water for at least 15 minutes. If irritation persists, get medical attention.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

HANDLING: Avoid breathing fertilizer mists. Avoid prolonged or repeated skin contact. Avoid eye contact. Wash hands thoroughly after using this product and before eating, drinking, chewing gum, using tobacco or using the toilet.

STORAGE: Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed, and food products, and seed. Store at ambient temperatures. Do not contaminate water, food, or feed by storage or disposal.
