## 4. FIRST AID MEASURES

### 4.1 Description of First Aid Measures

## 5. FIRE FIGHTING MEASURES

### 5.1 EXTINGUISHING MEDIA:

Suitable Extinguishing Media:

Dry chemical, carbon dioxide (CO<sub>2</sub>), alcohol foam, foam, water spray or fog. Do not use water jet as this will spread the fire.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to Remove residual contamination.

Never return spills to original containers for re-use.

### 7.1 PRECAUTIONS FOR SAFE HANDLING:

Advice on Safe Handling:
