Hydra-Hume® DG is a leonardite mix rich in humic acids. Products containing humic acids, such as Hydra-Hume® DG, may increase uptake of micronutrients.

SUGGESTED DIRECTIONS

Hydra-Hume® DG can be applied to all crops including: vegetable crops, row crops, field crops, trees and vines. Apply 40 pounds per acre per year. May be applied anytime during the year. First preference would be to broadcast in the fall after deep tillage. Second preference is to broadcast preplant up to first blossom.
