GENERAL INFORMATION

FOLI-GRO® Ca-Zn is formulated primarily for foliar applications to prevent or correct calcium and zinc deficiencies in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality.

Application of **FOLI-GRO Ca-Zn** is a means of obtaining a quick response to needed elements. Foliar applications of **FOLI-GRO Ca-Zn** may be particularly beneficial during periods of peak nutrient demand, for crops grown on soils having poor nutrient availability or to crops suffering from a weakened root system. Avoid foliar nutrient applications to crops during periods of moisture, salinity or heat stress. Applications of foliar nutrients to sensitive crops such as leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury.

FOLI-GRO Ca-Zn should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality.

DIRECTIONS FOR USE

FOLIAR APPLICATIONS: **FOLI-GRO Ca-Zn** has been formulated specifically for foliar applications. Soil applications are generally not advised.

Since both calcium and zinc move only a very short distance in plant tissues from the point of absorption, repeat applications of **FOLI-GRO Ca-Zn** should be considered for maximum effectiveness. Always include a high quality wetting agent, such as R-11®, at recommended rates.

Optimum rate of application will vary based on a variety of factors including degree of need or deficiency, growth stage, yield potential, environmental conditions, existing soil fertility levels, etc. **FOLI-GRO Ca-Zn** may be applied to all field, row, tree and vine crops as well as ornamental species and turf.

GROUND APPLICATIONS: It is recommended that **FOLI-GRO Ca-Zn** be applied in a minimum of 20 gallons of water per acre.

AERIAL APPLICATIONS: A minimum of 5 gallons of water per acre is advised when applied by air. If lower volumes are used, some leaf spotting may result.

FOLI-GRO Ca-Zn is formulated as an acidic solution and may reduce final spray solution pH depending on rates, carrier volume and water quality. For this reason, always test spray solution pH before adding acidifiers or buffer adjuvants. Use caution with high use rates when applications are made during periods with high temperatures.

COTTON: Apply 2-4 quarts per acre at square to peak bloom to aid in fruit retention.

CUCURBITS: Apply 2-4 quarts per acre as needed. Allow a minimum of 14 days between applications.

GRAPES: Apply 2-4 quarts per acre by ground post-bloom and as needed in season. Allow a minimum of 14 days between applications. Do not apply to fresh market varieties after fruit formation.

ROW AND FIELD CROPS: Apply 2-4 quarts per acre as needed, allowing a minimum of 14 days between applications.

TREE CROPS: Apply 2-4 quarts per acre as needed.

TOMATOES, PEPPERS, POTATOES: Apply 2-4 quarts per acre as needed allowing a minimum of 14 days between applications.

VEGETABLE CROPS: Apply 1-2 pints per acre. Allow a minimum of 7 days between applications at the 1-pint rate and 14 days between applications at the 2-pint rate.

FOLI-GRO Ca-Zn is compatible with many co-applied nutrient sources as well as plant protection products. Always jar test new combinations for compatibility prior to field mixing. **FOLI-GRO Ca-Zn** is generally incompatible with sulfate and phosphate fertilizers and fixed copper fungicides. **FOLI-GRO Ca-Zn** is formulated as an acidic solution and may reduce final spray solution pH depending on rates, carrier volume and water quality. For this reason, always test spray solution pH before adding acidifiers or buffer adjuvants.
