**ALIGN™** is a highly concentrated synthetic foam blend containing special additives to give it extreme durability under adverse weather conditions. **ALIGN™** is designed to work well in most all water conditions without the addition of chemical softeners or treated water. **ALIGN™** will produce a tight, highly dense foam mass in a number of environmental conditions. **ALIGN™** also contains optical brighteners for added brilliance and visibility.

### SUGGESTED USAGE RATE

**ALIGN™** may be used at dilutions that range from 120:1 to 80:1.

The normal use rate in most water conditions will be:

- 100:1 or 64 fl. oz. (1/2 gallon) of **ALIGN™** to 50 gallons of water.
- If foam is runny add more **ALIGN™** in small increments until desired consistency is achieved.
- If foam is too thick, thin mixture with water.
