DIRECTIONS FOR USE:

Apply foliar or to soil 1-2 quart of AGRO GOLD per acre at planting and every 3-4 weeks thereafter during season. Apply through drip, micro jet, overhead irrigation or broadcast with sufficient water to provide thorough penetration to root zone.
