

SURF-90

Non Ionic Surfactant



GENERAL INFORMATION

SURF-90 is a general purpose non-ionic surfactant of the alkylaryl polyethoxyethanol type surface active agents. It can be used with most insecticides, fungicides, herbicides, acaricides, defoliants, desiccants and wettable powders to improve performance of the active spray ingredient by giving them more uniform distribution and better wetting of the plant surface.

DIRECTIONS FOR USE

ACARICIDES, INSECTICIDES, FUNGICIDES - AERIAL AND GROUND

Application: Use 1 - 4 pints of **SURF-90** per 100 gallons of spray unless instructed otherwise by the accompanying pesticide label. Some pesticides limit the rate to 4-8 oz / 100 gallons of spray.

HERBICIDES, DEFOLIANTS, DESICCANTS, FOLIAR NUTRIENTS: Use 1 to 4 pints of **SURF-90** per 100 gallons of spray.

NOTE: The above recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher rates for optimum effect. Follow the pesticide label directions when this occurs. However, do not add this product at a rate which exceeds 0.50% (one-half) of the finished spray volume.

MIXING INSTRUCTIONS

For wettable powders and water-soluble materials, add this product in water before adding pesticide to spray tank. For emulsifiable products, add this product after a good emulsion is formed.

FIRST AID

Warning: Causes eye irritation. Harmful if swallowed. Avoid contact with skin, eyes or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or smoking tobacco. Remove and wash contaminated clothing before reuse.

PERSONAL PROTECTIVE EQUIPMENT

Applicators and other handlers must wear: Chemical-resistant gloves, long-sleeved shirt and long pants, and shoes plus socks.
