RESTRICTED USE PESTICIDE

In the states of Colorado, Kansas, Missouri and South Dakota, a section 24(c) has been established that has more restrictive conditions on the use of this product. DIRECTIONS FOR USE

STORAGE

CONTAINER DISPOSAL

RETURNABLE – REFILLABLE CONTAINERS AND BULK CONTAINERS

BALANCE® PRO Herbicide may be repackaged by Bayer CropScience or a registered establishment in accordance with a valid Bayer CropScience *BALANCE® PRO Field Load System and Micro Weigh System Use Agreement*. After use, return the container to the authorized repackaging facility for refilling or rededication according to the use agreement. **DO NOT REUSE THE CONTAINER FOR ANY OTHER PURPOSE.** Prior to refilling, inspect thoroughly for damage such as cracks, punctures, abrasions and damaged or worn out threads on closure devices. Do not refill or transport damaged or leaking containers. Check for leaks after refilling and before transportation. If the container is not being refilled or returned to the authorized repackaging facility, triple rinse the emptied container and offer for recycling or reconditioning, or dispose of in a manner approved by state and local authorities.
