SECTION 11: TOXICOLOGICAL INFORMATION

HEALTH EFFECTS: May be irritating to the nose, throat, and respiratory tract, and may cause sore throat, coughing, and shortness of breath. Skin irritation may result; repeated or prolonged skin exposures may result in dermatitis. May also be irritating to the eyes, causing redness and watering.
