GENERAL INFORMATION

TOTAL K is a high analysis liquid potassium fertilizer which can be soil applied as well as foliar applied. TOTAL K is highly soluble.

APPLICATION

Foliar: On vine, field, vegetable and tree crops, apply TOTAL K at 2 to 6 quarts per acre each application, first at pre-bloom, then post-bloom, mid-season and pre-harvest. TOTAL K is intended to be used as a supplement to a soil applied fertilizer program. Use this product in at least 10 gallons of water for each gallon of TOTAL K.

Soil: On field crops, grains and vegetables, apply a side dressing of 2 to 8 quarts per acre at least 3 inches from the plant.
