DIRECTIONS FOR RATES, FREQUENCY and METHODS

Agricultural:

In soil applications, used alone or in a blend formulation with other products, base the rate of 0.5 oz. – 1 oz. per acre on irrigation cycle requirements and soil type. General application rate per acre guidelines for 7-day irrigation schedules for soil types; fine - 3.5 oz., medium - 5.25 oz. and coarse – 7 oz. Apply in sufficient water to obtain lateral and vertical distribution uniformity into crop feeder root zones.

Turf and Ornamental:

Apply 128 oz. per 100,000 sq. ft every 15-30 days in sufficient water to obtain lateral and vertical distribution uniformity into turf or plant feeder root zones.

Application Methods:

May be applied thru standard irrigation systems or as an over-the-top surface spray with sufficient amount of water to follow immediately.

The rate, frequency, water requirement and method of applications for Agricultural, Turf and Ornamental uses may depend on; crop, turf or plant type, soil profile, weather and local growing conditions.
