

TREE NUT CUTICLE SUPPLEMENT

MONDO™ is a food-grade coating that is applied to nut crops to supplement the leaf cuticle during periods of rapid growth and stress. The leaf cuticle is responsible for protecting the tree against external stresses, desiccation or excess water loss.

FIRST AID	
If in Eyes:	Rinse with slowly and gently running water for 15-20 minutes. If wearing contacts remove after five (5) minutes of rinsing and then continue rinsing. If irritation persists get medical attention.
If Swallowed:	Give large quantities of water. DO NOT induce vomiting. Never give anything by mouth to an unconscious person. Get medical attention.
If on Skin:	Remove contaminated clothing. Thoroughly wash exposed skin area(s) with soap and water. If irritation occurs get medical attention. Do not reuse contaminated clothing until washed and cleaned.
If Inhaled:	Remove individual from area. Give symptomatic and supportive care if required. Get medical attention.

GENERAL USE RECOMMENDATIONS

MIXING INSTRUCTIONS:

With the agitator running, slowly add MONDO to the tank. Mix a minimum of 1 gallon of MONDO for each 100 to 200 gallons of water. Do not use less than 1 gallon of MONDO if spray volume drops below 100 gallons.

TANK MIXES: MONDO is compatible with most commonly used agricultural products and can be tank mixed. However, do not tank-mix with surfactants, stickers or pinolene based materials. Contact your Cultiva™ Specialist for advice on mixing with specific products.

USE INSTRUCTIONS FOR TREE NUTS (ALMONDS, PISTACHIO, WALNUTS, PECANS)

APPLICATION GUIDELINES: For maximum efficacy, all leaves and nuts must be covered with MONDO. To ensure better coverage, the ground speed of the sprayer should not exceed 2 miles per hour during spraying. Spray 100 – 200 gallons of MONDO mixture per acre via an air blast sprayer. Do not apply MONDO using ULV or electrostatic sprayers. Consider orchard characteristics such as tree size and shape to determine the spray volume that provides the best coverage. Air temperature during application should not exceed 85°F (29°C).

STORAGE AND HANDLING

Storage: Protect from freezing. Store in a cool, dry, shaded area away from children and animals. Store above 50F.

Spills: Surround and dike area of spill. Prevent runoff into streams, other waterways, or sewer systems. Soak up spill and place in containers. Wash contaminated area with soap and water.

Disposal: Dispose of material and rinsate as directed by local, state, or federal authorities. Keep out of streams and other waterways.

TIMING: For best results, apply MONDO in a three application program with the first application at petal fall. Reapply MONDO at 21 – 30 day intervals for a total of three applications.
