To prevent *Poa annua* and fall germinating chickweed, apply product to dry foliage in late summer/early fall (before germination). Repeat application yearly for continued control. A repeat application made after Poa annua treatment should not be sooner than 4 months.

Where lower infestations are expected, the lighter rates may be used.

Apply product uniformly to dry foliage at the suggested rate with a properly calibrated spreader.
