#### In Furrow Application

##### Corn (Field, Sweet, and Hybrid Seed Corn\*) and Soybeans only

Applications of Evito 480 SC should be made at application rates of 0.11-0.16 fluid ounces per 1,000 row feet when applied in furrow, in carrier volumes of 3-20 gallons per acre. See Table 1 for fluid ounces of product per acre for given row spacing. Apply Evito 480 SC directly in furrow or in a directed band prior to press-wheel closure. Seedling diseases are generally controlled by in furrow applications while banded applications are more effective against soilborne diseases that develop later in the season. Do not apply directly to humans or animals. Do not exceed a maximum of 22.8 ounces per acre of the active ingredient in Evito 480 SC, fluoxastrobin, per crop cycle.
