Directions for Use

¹ Bulb vegetables (Crop Group 3-07) including chive, fresh leaves; chive, Chinese, fresh leaves; daylily, bulb; elegans hosta; fritillaria, bulb; fritillaria, leaves; garlic, bulb; garlic, great-headed, bulb; garlic, serpent, bulb; kurrat; lady's leek; leek; leek, wild; lily, bulb; onion, Beltsville bunching; onion, bulb; onion, Chinese, bulb; onion, fresh; onion, green; onion, macrostem; onion, pearl; onion, potato, bulb; onion, tree, tops; onion, Welsh, tops; shallot, bulb; shallot, fresh leaves; cultivars, varieties, and/or hybrids of these.

Vindicate may be applied alone or in combination with dry urea or ammoniacal fertilizers (such as AMS, MAP, DAP) and liquid fertilizers (such as UAN, aqua ammonia, other liquid ammoniacal or urea nitrogen fertilizers), insecticides, fungicides, herbicides, and/or water.

Use Vindicate at 35 to 70 fl oz (0.5 to 1.0 lb ai nitrapyrin) per acre applied as a broadcast or banded application applied to the soil or through chemigation equipment as outlined in this label, up to 45 days prior to harvest. Alternatively, apply one application at 35 fl oz up to 75 days prior to harvest followed by one application of 35 fl oz up to 45 days prior to harvest.

The rates specified are on a broadcast per acre basis. For application methods other than broadcast, per-acre rates must be concentrated in the treatment area such as the bed or band.

Restrictions

- **Preharvest Interval:** Any application of Vindicate must be applied no later than 45 days prior to harvest.
- Do not apply more than a total of 70 fl oz (1.0 lb ai nitrapyrin) per acre per year.

- **Replant Restriction:** All crops (except for root and tuber crops) may be planted 30 days or more after last Vindicate application. Root and tuber crops are not to be planted less than 45 days after last application.
