GENERAL INFORMATION

CNI MSO™ is an active premium blend of methylated seed oil and non-ionic surfactants. It provides superior spreading, penetration and activation of herbicides, as well as with other pesticides and/or fertilizers. CNI MSO™ is designed for use with agricultural chemical spray programs to optimize product performance by increasing leaf penetration while giving a more uniform distribution of the active materials.

PRECAUTIONARY STATEMENTS

Hazardous to humans and animals. Causes serious eye irritation. Causes mild skin irritation. May be harmful if swallowed. May be harmful in contact with skin. May be harmful if inhaled. When mixing or apply agricultural sprays, always wear protective spray goggles and impervious gloves plus protective clothing as recommended on pesticide labels. FIRST AID

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Rinse Mouth. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything to an unconscious person.

IF IN THE EYES: Immediately flush eyes with plenty of water, lifting the eyelids and rinse for 15-20 minutes. Remove contact lenses, if present, then continue rinsing. If eye irritation persists get medical attention or call Poison Control Center for advise.

IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 10-15 minutes. Get medical attention if irritation develops or persists. Wash contaminated clothing before reuse.

PERSONAL PROTECTIVE EQUIPMENT

Wear long sleeved shirt and long pants, impermeable or chemical resistant gloves, protective eye wear (goggles or face shield), and shoes plus socks. User should wash hands before eating, drinking, chewing gum, using tobacco or using tollet. Remove clothing immediately if pesticide gets inside. Wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. As soon as possible, wash thoroughly and change into clean clothing.

DIRECTIONS FOR USE

Preperation of Spray Material

1. Fill spray or mix tank with 1/2 to 3/4 the desired amount of water.

Start mechanical or hydraulic agitation.

2. Add the required amount of pesticide.

3.Add the remaining volume of water and mix contents thoroughly.

4.Add the required amount of CNI MSO™ last and continue agitation until a uniform mixture is obtained.

NOTE: Maintain constant agitation of spray mixture during standing and application to assure uniform pesticide application.

Defoliants, Desiceants: Use 1 to 4 pints of CNI MSO™ per acre in combination with the recommended defoliant or desicoant. Insecticides & Fungicides: Use 1/2 to 2 pints of CNI MSO™ per acre in combination with the recommended fungicide or insecticide.

Herbicides: Use 1 to 4 pints of CNI MSO™ per acre in combination with the recommended herbicide. NOTE: The above use recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher rates for optimum effect. Follow the pesticide label directions when this occurs. However, do not add this product at a rate that exceeds 5% of the finished spray volume.

COMPATIBILITY: This product may be used with wettable powder, emulsifiable concentrate or solution formulations of most of the pesticides and insecticides now on the market.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Keep in original container. Store in cool, dry place. Keep locked up and away from children. Do not reuse empty container. Triple rinse during mixing and loading and add rinse water to spray tank. Offer decontaminated containers for recycling Contact county agricultural commissioner for container disposal information.
