### **General Information**

BRANDT ENZUP 12-58-0 contains a concentrated water soluble enzyme and two primary plant nutrients designed to correct phosphate deficiencies. The phosphatase enzyme, naturally produced by some plants, cleaves phosphate from organic matter, making it available for plant uptake. This product rapidly disperses 100-1200 times more enzymes than what is naturally present in the soil, resulting in improved release from organic phosphate pools. It will quickly boost plant growth during critical or high growth periods.

This product is designed for dissolving in water and applied through fertilizing equipment, injected into irrigation systems into actively growing root zones, or injected near the seed during planting. It has a low salt index, so it is ideal for use as a starter or sidedress fertilizer applied directly to the soil.

BRANDT ENZUP 12-58-0 is recommended for use on, but not limited to, vegetable and row crops, deciduous fruit and nut trees, citrus, avocados, vine and berry crops, ornamentals, turf, pasture, range grasses and most other crops.

# **Mixing and Handling Instructions**

**Compatibility:** BRANDT ENZUP 12-58-0 may be applied separately or in conjunction with most other fertilizers. A compatibility test is recommended if the desired combination has not been previously used. DO NOT use this product with ammonium thiosulfate, potassium thiosulfate or other high pH or high free-ammonia products.

WARNING: When mixing with UAN solutions, add one gallon of water for every one gallon of UAN solution and blend well before adding BRANDT ENZUP 12-58-0 to insure complete and thorough mixing.

**Mixing:** Dissolve the recommended amount of BRANDT ENZUP 12-58-0 into approximately one half the required water. Slowly add the remaining water while maintaining constant agitation.

Water quality and temperature will determine maximum solubility. Warmer water temperatures increase solubility and shorten dissolving time. As this product goes into solution, the water temperature will drop. Therefore it is important when preparing concentrated solutions to allow for this temperature drop to insure that the fertilizer is completely dissolved.

### **Rate Recommendations**

Dissolve 5-30 pounds in sufficient water to treat one acre. DO NOT exceed 1 lb. BRANDT ENZUP 12-58-0 per gallon of water. Repeat as needed.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden, and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
