PRODUCT INFORMATION:

STIMULAGRO GOLD is an enhanced formulation made from organic concentrated water soluble liquid extract of cold water seaweed (*Ascophyllum Nodosum*) and a biological amendment containing soil enhancing bacteria and high levels of auxins, betaines and cytokinins for use all crops, turf and ornamentals.

DIRECTIONS FOR USE:

Application Rate: 1 qrt per acre with sufficient water to ensure penetration to root depth. Apply

foliar or to soil at planting and 2 to 3 times during the growing season for vegetable crops and row crops. Apply monthly to turf and every other month on fruiting tree crops maximum 4 to 5 application per year.

Consult with your agronomist or sales rep for more specific dosage.

Do not apply when rain is expected or irrigation is planned.

Always perform compatibility jar test prior to mixing with other chemicals.

SHAKE BEFORE USE.

PRECAUTIONS:

Avoid getting in eyes or on skin or clothing. The use of side-shield safety glasses and gloves is recommended. Harmful if swallowed. If skin contact occurs, remove contaminated clothing and wash with large amounts of soap and water. If in eyes, rinse repeatedly with clean water for 15 minutes. Obtain medical attention for any persistent irritation.

CONTAINER DISPOSAL:

STORAGE:
