### GENERAL INFORMATION

BLENDER is formulated to increase liquid fertilizer compatibility with various pesticides including emulsifiable concentrates and wettable powders

### DIRECTIONS FOR USE

For the following fertilizer blends, use BLENDER at a rate of 0.25 to 1.0% of the total mix.

24-0-0	10-34-0	28-0-0
11-37-0	7-21-7	8-8-8
32-0-0	8-16-8	8-12-0
5-10-10	20-4-0	

High phosphate fertilizers require the higher percentage concentration of BLENDER in the mix. It may be best to dilute the high phosphate blend water and add this blend to the tank after the BLENDER and the pesticide have already been blended.

High nitrogen fertilizers require the lower percentage concentrate of BLENDER in the mix.

Medium phosphate or phosphate/ potassium solutions require 0.50 to 1.0% BLENDER to total mixture.

#### FIRST AID:
