

PRECAUTIONARYSTATEMENTS:

Keep away from heat / sparks / open flames / hot surfaces. No smoking. Keep container tightly closed. Ground / bond container and receiving equipment. Use explosion-proof electrical /ventilating/ lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Avoid breathing dust / fumes / gas / mist / vapors / spray. Wash thoroughly after handling. Do not eat, drink or smoke when using this product. Use only outdoors or in a well-ventilated area. Track-It is specifically formulated to maximize marking foam performance in pressurized marker systems by generating greater volumes of heat-stable marking foam under a wider range of operating pressures than ordinary synthetic marking foams. Track-It's high expansion formulation produces large volumes of thick, long-lasting foam that allows applicators to drop more foam at higher operating pressures and application speeds. In side-by-side field tests, Track-It has outlasted ordinary marking foams by over twice as long.

DIRECTIONS FOR USE

Thoroughly clean and neutralize application unit foam tank with an approved foam tank cleaner, such as AGRI-KLEEN™, prior to using Track-It for the first time. Track-It is tolerant to hard water conditions and does not require an additional water softener. SHAKE WELL BEFORE USING.

DOSAGE:

Use Track-It at a 100:1 dilution rate (12–13 ounces of Track-It per 10 gallons of water).
