DIRECTIONS FOR USE

It is a violation of federal law to use these products in a manner inconsistent with labeling.

As part of an integrated approach to reducing yield losses in potato, Bayer recommends the following components to manage potato early dying and Verticillium wilt.

- Emesto Silver applied as a seed piece treatment* (0.31 fl oz per 100 lbs of seed)
- Velum Prime applied in furrow at plant* or in an early-season chemigation (6.5 to 6.84 fl oz/acre)
- Luna Tranquility applied broadcast once or twice in the season as a foliar chemigation or spray (11.2 floz/acre)

Potato early dying and Verticillium wilt: Emesto Silver, Velum Prime, and Luna Tranquility each demonstrate significant suppressive effects on *Verticillium dahlia*, and on multiple contributing components of potato early dying. Combinations of these products have resulted in improved disease and nematode suppression. Velum Prime and Luna Tranquility have been shown to reduce *Verticillium dahlia* populations in stems and tubers, and have been shown to reduce overwintering soil populations and disease in subsequent plantings. No activity on bacteria would be expected from these treatments.

* Note: Emesto Silver and Velum Prime (in-furrow method) are not trade enabled in all key export markets. Recommended for use only on potatoes to be consumed in the US, Canada, and Mexico. All potato by-products must be used in the US, Canada, and Mexico.
