KayRx is formulated to provide plant-available potassium for all crops. KayRx can be used for foliar and soil applications on field, vegetable, row, fruit, tree, vine, ornamental and turf crops. KayRx may be applied alone or with fertilizers or pesticides.

KayRx is compatible with most pesticides and fertilizers. However, a compatibility test is recommended if the desired combination has not been used in the past.

#### **DIRECTIONS FOR USE**

**Shake well before using.** *KayRx* is designed as a foliar or soil treatment. It may be run through irrigation systems.

#### APPLICATION RATE RECOMMENDATIONS

**SOIL APPLICATION:** Apply 2-4 qts per acre in combination with fertilizer program.

**FOLIAR APPLICATION:** Apply 2-4 qts per acre in combination with fertilizer program.

Repeat at 2-3 week intervals or as needed.

#### STORAGE & DISPOSAL

Store product in original container tightly closed, upright, in a dry place, **DO NOT** store in excessive cold or heat. **DO NOT** reuse container. **DO NOT** contaminate water, food or feed by storage or disposal. Triple rinse or equivalent and dispose of container in accordance with local, state and federal regulations.
