Disease Pre-Plant Application

Timing:

For the suppression of Pink Root disease, apply Fontelis® at 24 fl oz per acre as a broadcast or band spray over the seedbed prior to planting and incorporate to a depth of 1-2 inches using mechanical incorporation equipment or incorporate using overhead irrigation by applying at least 0.5 inch of irrigation water.

Post-Plant Timing:

For best results, apply Fontelis at 24 fl oz per acre after planting before seedling onions are beyond the 3 leaf stage. Because Pink Root is a soil borne disease, it is important to protect seedling plants before they become heavily infected. Treatments made after the 3 leaf stage may not be as effective as the Pre-Plant application timing. Post-plant application can be made as a broadcast or banded spray and incorporated via overhead irrigation using at least 0.5 acre inches of water or via overhead chemigation (0.25 -0.5 inches water/ac).
