Blend *Esteem* Ant Bait with dry granular fertilizers for ant control in food and feed crops and non-crop areas.

A second application may be needed in 12 to 16 weeks in areas with heavy infestation, or when mounds remain active, or when reinfestation occurs. |

Restrictions

- For Pasture Grass and Rangeland, the pre-harvest interval (PHI) is 0 days.
- For all other uses, do not apply within 24 hours of harvest.
- Do not apply if rain is expected within in 4 to 6 hours of treatment.
- Do not water treated area within 24 hours of treatment.
- If long periods of rainfall occur after treatment, reapplication may be required.
