

DIRECTIONS FOR USE

Apply at 3-9 fl oz/acre; recommended 1 application up to 3 applications per growing season. Fill mixing tank to a minimum of 50% volume, begin agitation, add Rhizolizer Duo, and fill with remainder of required volume. Agitate throughout application.

Rhizolizer Duo should be used within 8 hours of mixing. It can be applied with some agricultural fertilizers and blends. Contact Locus AG to ensure compatibility.

Do not tank mix with or apply directly after agricultural fungicides or antimicrobials. Do NOT tank mix with UAN-32 or UAN-28. Can be applied with 10-34-0 and 6-24-6. Not recommended for use as a fertilizer. Conduct a jar test to assure tank mix compatibility.

Corn/Sovbeans/Grain Sorghum:

Apply 6 fl oz/acre application at planting in furrow or 2x2 band. It's also acceptable to apply with most starter fertilizers, but not with UAN-32 or UAN-28

Apply 6 fl oz/acre at midseasc through center pivot or subsurface irrigation. Contact Locus rep for specific recommendations on crop

Cereal Grain:Apply 3 fl oz/acre at planting

Cotton/Sugar Beet:

Apply 3-6 fl oz/acre at planting
Other Crops:

Apply 3-6 fl oz/acre at planting

Irrigated Applications:

Apply 6 fl oz/acre at midseason through center pivot or subsurface irrigation. Contact Locus rep for specific recommendations on crop growth stage application timing. For preemergence applications and broadcast applications, use a minimum of 20 gallons of water per acre to ensure product reaches rootzone. Avoid tank mixes with UAN.
