SUGGESTED DIRECTIONS

RESURGE™ PROFESSIONAL can be applied to all crops including: trees, vines, ornamentals, turf, lawns and garden landscaping.

Apply 40-80 pounds per acre per year.

WARM SEASON GRASSES: 1-2 lbs/1,000 sq. ft. in early spring and late fall. Problem spots may benefit from additional applications.

COOL SEASON GRASSES: Use at 1-2 lbs/1,000 sq. ft. as a top-dress after aeration. Mix with sand media if possible.

TREES, SHRUBS, WOODY ORNAMENTALS AND BEDDING PLANTS:

Ring 2-8 oz. around base of trees and shrubs. Use higher rates on larger species. Broadcast 1-2 lbs/1,000 sq. ft. into ornamental beds.

FOR USE IN GRANULAR APPLICATION EQUIPMENT: Apply 6-20 lbs. per acre in-furrow or banded application.
