CobaFORCE-H3 is a source of Cobalt chelated with EDDHA readily available to the plant in Alkaline, Acidic and Calcareous soils. **CobaFORCE-H3** most effective application time is during vegetative plant growth. **CobaFORCE-H3** should be applied in the roots zone through drip irrigation or side dressing and can be easily mixed with most chemicals or fertilizer without reacting with other materials.

SOIL APPLIED: CobaFORCE-H3 is a readily available source of chelated Cobalt which performs in alkaline, acidic and Calcareous soils. Water run 4-32 ounces / minute. Apply 4 to 15 ounces per Acre in at least 25 gallons of water. Cobalt is a copper antagonist, apply extra copper in foliar application.
