## Directions For Use

1. Stir well or agitate product prior to use.
2. Fill mix tank one-half to two-thirds full with water. Start and maintain constant agitation throughout entire mixing and treating process.
3. Add seed treatment materials, **Color Coat™** Colorant and **Flo Rite®1197**.
4. Bring the volume of slurry treatment mixture to the desired volume, with water.

**Do not apply to grain used for food or feed purposes or processed for oil.**

## Usage Rates\*

**Field Corn** – 2.0 fluid ounces per hundred weight (flat rate), 0.46-2.2 milligrams per kernel (per seed rate)

**Wheat** – 2.0 fluid ounces per cwt

**Sunflowers** - 6.0 fluid ounces per cwt

### EXAMPLES:

When applied with neonicotinoid insecticide products at 0.25 mg ai /seed, apply **Flo Rite 1197** at 0.46 mg /seed (2.0 fl oz/cwt based on 1400 kernels/pound).

When applied with neonicotinoid insecticide products at 0.5 mg ai /seed, apply **Flo Rite 1197** at 0.92 mg/seed (4.0 fl oz/cwt based on 1400 kernels/pound).

When applied with neonicotinoid insecticide products at 1.25 mg ai/seed, apply **Flo Rite 1197** at 2.2 mg /seed (9.5 fl oz/cwt based on 1400 kernels/pound).

\*Suggested rates. Some variation may occur. Adjust the rates to obtain the desired coverage due to seed size, seed coat, conditioning equipment and total slurry.

## Storage and Disposal

**Storage:** Segregate from foods and animal feeds. Keep away from heat. Protect from direct sunlight.

**Waste Disposal of Substance:** Must be disposed of or incinerated in accordance with local regulations.
