Control of Root Knot (except Javanese), Stubby Root, Stem and Bulb Nematodes

Broadcast Treatment

Apply 2 gals. of Vydate L per acre in a minimum of 20 gals. of water per acre as a broadcast treatment to the soil using ground application equipment. Apply within one week of planting. Thoroughly incorporate to a depth of 4 to 6 inches in the soil.

In-Furrow Treatment
