When following the instructions on this supplemental label, the user must have this label and the entire **Liberty 280 SL container label** in possession at the time of pesticide application.

Application Restrictions

- Users must comply with the North Dakota Department of Agriculture Seed Policy.
- **DO NOT** apply more than three applications of **Liberty 280 SL** at up to 24.5 fl ozs/A per application per growing season.
- **DO NOT** apply more than 73.5 fl ozs/A of **Liberty 280 SL** per growing season.
- **DO NOT** apply beyond the early bolting stage or within 65 days of harvesting canola seed.
- **DO NOT** use treated canola seed for food, feed, or oil purposes.
- **DO NOT** apply if canola shows injury from prior herbicide applications or environmental stress (drought, excessive rainfall, etc.).
- **DO NOT** apply this product through any type of irrigation system.
- Refer to the **Rotational Crop Restrictions** section of the **Liberty 280 SL** herbicide label for the appropriate rotational crop plant back intervals.

Product Information

Liberty® 280 SL herbicide may be used in canola seed propagation as a foliar spray to selectively eliminate canola plants that do not carry a gene that imparts tolerance to glufosinate-ammonium and, as such, can be applied to remove susceptible segregates during canola seed propagation. Breeding material not possessing the glufosinate-ammonium tolerance gene will be severely injured or killed if treated with this herbicide.

Apply **Liberty 280 SL** only to canola labeled as **LibertyLink®**. Uniform, thorough spray coverage is necessary to achieve consistent activity.

Application Rate and Timing

Up to three applications of **Liberty 280 SL** at up to 24.5 fl ozs/A per application may be made to canola for seed production. Applications may be made from the cotyledon stage up to the early bolting stage (e.g., BBCH 18 to 30, between just prior to stem elongation/bolting, eight or more leaves and beginning of stem elongation, no internodes).
