LABEL USAGE RECOMMENDATIONS

- Shake well before use
- Dilute one part of the product with 99 parts of water.
- Apply 100 gallons of the diluted product to one acre. (1000L/hectare).
- Adjust application rate and spray on cherry trees adequately to ensure complete coverage of the cherries.

TIMING OF APPLICATION FOR CHERRIES

First Application: Right before color breaks to a straw color.
Second Application: 7-10 days later after the first application.

Caution: Product must dry for 24hrs on cherries before a rain event, reapply product if rain event occurs within 24hrs from the treatment. If other chemicals are tank mixed allow 48-72hrs for drying.

For tank mixing with other chemicals, first test compatibility. Apply during the cooler hours of the day.

Recommended doses are the result of test and common practice, but results may be affected by external conditions and cultivar susceptibility.
IN CASE OF MIXTURE WITH OTHER PESTICIDES TEST COMPATIBILITY.

HANDLING AND STORAGE RECOMMENDATIONS

- Avoid contact with skin, eyes and clothing
