4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

Spill Cleanup: Reduce airborne dust. Sweep up spill and place in an appropriate container for disposal. Wash area with soap and water. Collect washings for disposal.

7. HANDLING AND STORAGE
