To Increase Fruit Size in Sweet Cherries [Not For Use in California]

Apply 0.7 to 1.4 ounces (20 to 40 grams) of Provide 10 SG per acre in an application volume of 100 gallons of water per acre (5 – 10 ppm), in 1 to 4 consecutive applications. The first application should be applied at white bud stage (i.e., first white, popcorn). One to three subsequent applications may be made at 7- to 14- day intervals up to petal fall.
