# **Guaranteed Analysis**

<u>General Information</u>: POWER-LINE 8% CU (N.F.) is a manufactured liquid nutrient. Its use is suggested as supplement to a regular balanced fertilizer program to enhance yields and improve quality.

Comptibility: POWER-LINE 8% CU (N.F.) is a compatible with neutral pH fertilizers and pesticides. However, a compatibility test is suggested if the desired combination has never before been used.

<u>Directions For Use</u>: Ground Sprayer Application: Ground application should not exceed 3 ounces per gallon of water. Do not exceed 2 pints of POWER-LINE 8% CU (N.F.) per acre. Apply the recommended amount with sufficient water to provide the desired coverage. When less than 10 gallons of water per acre is used foliage injury may occur.

<u>Arieal Application</u>: Arial application should not exceed 3 ounces per gallon of water. Use a minimum of 10 gallons of water per acre of POWER-LINE 8% CU (N.F.). If less water is used foliage injury may occur. Avoid spraying during high temperatures of when the humidity is very low. For safest and best results plants should be actively growing and free of stress.

Mixing Directions: Fill spray tank 1/3 to 1/2 with water. With agitator running add POWER-LINE 8% CU (N.F.). Agitate while adding remaining water and any other fertilizer. Add pesticide last and continue to agitate. Agitate well prior to spraying if mix has been left standing for a short time.

<u>Suggestions For Use</u>: Optimum rate of application will vary between fields. For best results, follow soil test or plant analysis. POWER-LINE 8% CU (N.F.) is intended for use in a balanced fertility program.
