### 4. FIRST-AID MEASURES

**First Aid Measures**

<b>General Advice</b>	When possible, have the product container or label with you when calling a poison control center or doctor or going for treatment.

**5. FIRE-FIGHTING MEASURES****Suitable Extinguishing Media**

<b>Methods for Clean-Up</b>	For small spills, absorb with sand, clay, or other inert absorbent. Place in appropriate containers for disposal. For large spills: recover free product. Dike for later disposal. Absorb with inert material, and then place in suitable container for chemical waste. Wash spill area with a strong detergent and water solution; rinse with water, but minimize water use during clean-up. Do not flush to sewer. Pick up and transfer to properly labeled containers.

### Precautions for safe handling

#### **Advice on Safe Handling**
