NOTE: Spraybor should be used on the basis of a soil and/or tissue analysis. Do not apply unless a deficiency or low Boron level is known to exist and is confirmed by visual symptoms or tissue analysis. Use diluted sprays and as low a rate as possible.

DIRECTIONS FOR USE: For use in balanced fertilizer programs for those crops requiring boron, e.g. Apples, Alfalfa, Corn, Flowers, Grapes, Onions, Potatoes, Sunflowers and Cole

SUGGESTED FOLIAR APPLICATION RATE:

Crop	Dosage Rate / Acre	Remarks
Apples and Pears;	2 - 5 lbs.	Apply in sufficient water to achieve good and thorough coverage. Usually 100 - 200 gallons of water per acre, depending on planting density and tree size. Use the higher rates to correct a known boron deficiency. Do not apply over 5 lbs. per acre per year.
Alfalfa	2 - 6 lbs.	Apply as maintenance overall spray treatment 10 days after cutting. Use the lower rate for sandy soils and the higher rate for clay soils.
Cole Crops, Cabbage, Cauliflower Broccoli, and Vegetable Seed production	0.5 - 3 lbs	Commence spraying when young plants are approximately 3 inches high. Repeat after 10 - 14 days.
Table Beets	0.5 - 3 lbs	Apply at the following rates: 1. Bulb enlargement 2. Beets 1½ - 2* in diameter 3. Additional applications may be applied 10 - 14 days later.
Clover, Grass Mixes	1 - 5 lbs	Apply after each cutting.
Potatoes	8 oz 1 lb.	Apply 3 sprays at 3 weekly intervals. Commence spraying at tuber initiation.
Sunflowers	1 - 2 lbs.	Apply as a full cover spray and repeat after formation of new leaves.
Onions	1 lb.	Apply first spray 3 weeks after plants are established and repeat 3 weeks after first spray.
Corn	1 - 2 lbs.	Commence spraying when plants reach knee height (10 - 20 inches tall) and repeat if necessary 14 days later. Use lower dosage rates on younger plants.
Grapes	1 - 1.5 lb.	Apply 2 sprays. Commence spraying prior to flowering and repeat 10 - 14 days later. Where necessary apply post harvest.
Raspberries, Blackberries, Blueberries Strawberries, and other small fruit.	0.5 - 3 lbs	Pre-bloom application. Repeat in 2-4 weeks as necessary. Late summer and fall application.
Cherry, Apricot Plum, Prune Almond, Peach, Nectarine, Walnut, Filbert (hazelnut), Pistachio, Pecan	1 - 5 lbs	1 - 5 lbs per acre pre-bloom. May repeat if necessary. Fall application: may apply 1 - 3 lbs/acre (before killing frost.) Dormant and Delayed dormant: 1 - 3 lbs/acre. Always consult Fieldman first.
Flowers & Ornamentals	15 oz. in 250 gal. Water	Apply 2 - 3 sprays, at monthly intervals, during the growing season. Start spraying as soon as plants are fully established.

Annual application at the low maintenance rate should supply sufficient boron to prevent deficiencies especially if applied before bloom. This will improve blossom quality and fruit set. Spraybor sprays can also be applied in the late full post-harvest while the leaves are green and active or in the early spring when blossom buds are developing. DO NOT apply high rates after May.
