#### PRODUCT INFORMATION

**SUNBurst® Liqui-K** is a liquid potassium fertilizer applied to plant foliage as part of a complete crop management program.

#### DIRECTIONS FOR USE

##### SHAKE WELL BEFORE USING.

**IMPORTANT NOTICE:** Read the entire label. Use only in accordance with the label instructions. Over application of **SUNBurst® Liqui-K Spray** may be phytotoxic or cause undesirable effects.

**For use in all crops:** Apply **SUNBurst® Liqui-K Spray** at a rate of 1 to 2 quarts per acre. Repeat application every 7 to 14 days or as needed throughout the growing season.

**Nursery:** Use 1 ounce per gallon of water or 1 quart per 100 gallons of water. Apply as a soil drench or spray plant foliage to the point of run-off. Repeat as needed.

**Turf:** Use 1 to 2 ounces per 1,000 square feet.

#### APPLICATION GUIDELINES

**pH:** Buffer the tank-mix to a pH of 6.0 to 7.0 prior to adding **SUNBurst® Liqui-K Spray** to the tank.

**SUNBurst® Liqui-K** is non-phytotoxic when used as directed. Always test a small plot before large-scale application.

**Compatibility:** **SUNBurst® Liqui-K** is compatible with most insecticides and pesticides and can be tank-mixed with Organic BioLink® Cal Plus. However before use, it is recommended that a standard jar test be conducted with any untried tank-mixes.

Always use best management and use practices when applying **SUNBurst® Liqui-K Spray**. Use additional fertilizers as needed, based on soil and tissue testing.

#### PRODUCT STORAGE & DISPOSAL

**STORAGE:** Store in a clean, dry place above freezing and below 110°F (43°C). Do not store in direct sunlight. Keep container tightly closed. Do not store diluted product.

**DISPOSAL:** Puncture empty container. Dispose of empty container and excess tank-mix spray according to Local, State and Federal regulations only.
