### DIRECTIONS FOR USE

#### TIME OF DAY TO SPRAY

**KOOLDOWN/4®** should be sprayed in the coolest part of the day/night in order to achieve maximum result. Do not spray in the heat of the day.

#### GENERAL APPLICATION RATES

**KOOLDOWN/4** should be sprayed as required. Contact your local Crop Production Services support representative for further advice.

**Cut Flowers, Tomatoes, Onions, General Row Crops, Bell Peppers, Grapes and Vines, Chiles, Vegetables, Potted & Exotic Plants, and Melons:** 5-7 quarts per acre.

**Citrus Fruits, Pears, Avocados, Plums, Bananas, Apricots, Mangos, Peaches, Nut Trees, Cherries, Apples, all larger sized trees and Pomegranates:** 6 quarts - 2 gallons per acre.

#### FIRST AID

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.
