**INSECTS:** To effectively repel aphids, spider mites, thrips, leaf miners, whiteflies, lace bugs, leafhoppers, scale, cabbage looper and beet armyworm, spray Hot Pepper Wax Ready-To-Use on foliage, stems, buds, fruits, and blooms. Hot Pepper Wax Ready-To-Use can be used on fruits, vegetables, citrus, root crops, legumes, indoor/outdoor ornamentals, and grasses.

**APPLICATION AND TIMING: SHAKE WELL;** Apply until foliage or surface is wet. Repeat application in 3–7 days for 2–3 weeks, until control is established.

**ONCE CONTROL IS ESTABLISHED,** use every 2–4 weeks, as necessary to maintain control.
