PRINCIPAL INGREDIENTS: Phosphoric acid and proprietary ingredients.

DIRECTIONS FOR USE

- Prepare use-solutions by adding approximately 1 gallon (3.8 liters) Mineral-XX to 100 gallons (380 liters) water.
- 2. Expose fruit in treatment water for 1-2 minutes.
- 3. Rinse thoroughly with potable water.
- 4. For optimum results, maintain use-solution at approximately pH 2-3.
- To ensure dispersion of Mineral-XX in dump tank water, regularly agitate solution.

NOTE: Chlorine reacts violently in the presence of acids. DO NOT add chlorine to submersion tanks containing Mineral-XX.

HANDLING: Causes severe skin burns and serious eye damage. May be harmful in contact with skin or if swallowed.
