## **Neutralizes Water Treated with Sodium Hypochlorite**

For Agricultural Use Only

**INGREDIENTS**: Potassium hydroxide and proprietary food grade ingredients.

#### **DIRECTIONS FOR USE**

For every 100 gallons of water containing 100 ppm sodium hypochlorite, add 8 ounces of PacRite Chlor Out to neutralize. Drain equipment and rinse with water after treatment.

**NOTE**: This will lower the pH of the water. If your wastewater requires a neutral pH for disposal, add 2 ounces of PacRite pH Increaser to every 100 gallons of treated water to return the water to a neutral pH level.

All dosage rates on this label should be considered approximate, as they can vary slightly according to local characteristics of water. Consult your PACE Technical Representative for specific rates and recommendations based on your water quality.

**HANDLING**: Causes severe skin burns and eye damage. Wear protective clothing, chemical resistant gloves, and safety glasses or face shield when using.
