DIRECTIONS FOR USE

1. PacRite Color Booster is recommended for use when processing rate falls below 600 boxes of fruit per hour.
2. Add PacRite Color Booster to the dye tank at the rate of 1 quart (1 liter) for each 500 gallons (1900 l) of dye solution per hour.
3. In operations that need Color Booster to maintain the solvent balance, a dose of 2 quarts per 500 gallons of solution is recommended at start-up any time the tank has been shut down for more than 18 hours.

IMPORTANT: Do not allow water to contaminate the contents of this container.

HANDLING: Wear goggles or face shield, protective gloves, and protective clothing when handling. Do not get in eyes, on skin, or on clothing. Do not inhale or swallow. Use ventilation adequate to keep exposures below recommended exposure limits. Keep closure up to prevent leakage. See MSDS for additional information.
