DIRECTIONS FOR USE

1. Apply Prima Fresh 60-OR directly or diluted on previously washed and dried fruit surface.
2. If diluted before application, use soft water. Dilution ratios may be adjusted to suit specific needs.
3. On nectarines, plums, peaches and other round fruits and vegetables, Prima Fresh 60-OR is applied by spraying over brushes or rollers at a rate of 1 gallon (3.8 liters) of concentrate per 20,000 - 25,000 pounds (9100 – 11,300 kg) of fruit.

NOTICE: Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled “Coated with food grade vegetable and/or shellac based resin or wax” on bulk and individual retail/consumer packages.
