DIRECTIONS FOR USE

Fruit Cleaning:

- 1. Dilute Shield-Brite® Vacate 1:32 with water (4 oz. Shield-Brite Vacate per gallon of water).
- 2. Apply by spray over brushes.
- 3. Rinse.

General Cleaning:

- Dilute Shield-Brite Vacate with water. Dilution can range from 1:5 to 1:32, depending on desired strength of cleaning solution. Consult your PACE representative for best results.
- 2. Apply with pressure spray.
- 3. Rinse.
